Methodological Handbook for VIPs Assistant and Mentors

This HANDBOOK represents a crucial resource for all parties engaged in the promotion of a more inclusive bakery industry.

It provides comprehensive guidance for visually impaired individuals aspiring to become bakery assistants and for companies seeking to integrate and train professionals capable of promoting and facilitating access to the work environment for disabled people.



This handbook will shortly be accessible online free of charge in multiple languages and with an audio version.

The Handbook is divided into two sections:

- The **first section** provides practical methodologies, useful tips and adaptable strategies to facilitate learning and practising baking for blind and visually impaired persons.
- The second section focuses on the importance of the mentor, a key figure who supports professional inclusion in the company. The manual is intended to facilitate the breaking down of barriers and the redefinition of the future of bakery employment, with the objective of making the work experience accessible and rewarding for all.

This Toolkit will provide Visually Impaired Bakery Assistants with the tools they need to work safely and effectively, while offering Mentors comprehensive guidance on digital devices and tools that can foster an inclusive work environment.
